■■ Battle Party LA LLC – Release of Liability, Assumption of Risk & Media Consent

READ CAREFULLY – THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS

1. Acknowledgment of Risks

I fully understand that risks and dangers exist in the use of recreational equipment and participation in related activities. These risks include, but are not limited to: falls, collisions, trips, impact from foam projectiles or blasters, eye or ear injury, dehydration, heat exposure, physical exertion, or other causes that may result in injury, illness (including communicable disease), paralysis, or death. Such risks may arise from my own actions or inactions, those of others, the condition of the premises, or the negligence of Battle Party LA LLC ("BPLA") and its staff. I voluntarily assume full responsibility for all such risks, whether caused by negligence or otherwise.

2. Release and Indemnification

I, for myself, my heirs, executors, and assigns, hereby release, waive, discharge, and hold harmless Battle Party LA LLC, its owners, officers, employees, contractors, agents, and affiliates from any and all liability, claims, or demands arising out of or related to participation in any Battle Party activities, including those arising from negligence. This release includes, but is not limited to: personal injury, property damage, or wrongful death; illness or communicable disease; or any act, omission, or negligence by Battle Party LA LLC or its representatives. This waiver remains valid through November 1, 2026, unless otherwise stated.

3. Age & Supervision Policy

Participants under the age of 5 are not permitted to engage in Battle Party LA activities unless a parent or legal guardian is physically present on the battlefield and remains beside the child at all times. Battle Party LA reserves the right to deny or remove participation for any minor under 5 who does not meet this supervision requirement.

4. Protective Gear Requirement

All participants under 18 years old must wear the protective gear provided by Battle Party LA at all times during gameplay. If a participant under 18 removes or fails to wear protective gear and is injured as a result, Battle Party LA is not liable for any resulting injuries or damages. Participants 18 years of age or older are not required to wear protective gear, though Battle Party LA will provide it and strongly recommends its use. If an adult participant chooses not to wear protective gear, they do so entirely at their own risk, and by participating, they acknowledge full responsibility for any injuries, damages, or losses that may occur as a result of not wearing the provided protective gear or while being on the battlefield. By signing this waiver, participants expressly waive any right to bring legal action against Battle Party LA LLC for injuries or damages sustained while participating without protective gear.

5. Media & Marketing Release

I understand and agree that Battle Party LA LLC reserves the right to photograph, film, and record participants during events. Such media may be used for marketing, social media, advertising, and other promotional purposes without compensation. If a parent or guardian wishes to opt out of this media consent, they must submit a written request to Battle Party LA prior to participation in the event.

6. Medical Authorization (Minors)

If the participant is under 18 years of age, the undersigned parent or guardian authorizes Battle Party LA to seek and obtain emergency medical treatment as deemed necessary during participation. I understand that Battle Party LA staff members are trained in basic CPR and First Aid but are not medical professionals. In the event of any injury or medical situation, staff will provide immediate basic care within their training and defer all final decisions and ongoing medical needs to the parent or legal guardian. When appropriate, emergency medical services (EMS) will be contacted.

7. Acknowledgment

I HAVE READ AND UNDERSTAND THIS RELEASE OF LIABILITY. I FULLY UNDERSTAND ITS TERMS AND SIGN IT FREELY AND VOLUNTARILY. I AM AT LEAST 18 YEARS OF AGE AND FULLY COMPETENT TO SIGN THIS AGREEMENT, OR I AM THE PARENT/LEGAL GUARDIAN OF THE PARTICIPANT NAMED BELOW.

8. Code of Conduct & Equipment Responsibility

All participants are expected to follow the safety rules and instructions provided by Battle Party LA staff at all times. Violent, hostile, or aggressive behavior toward staff, other participants, or property will not be tolerated. Any participant who knowingly or unknowingly disregards safety instructions, engages in unsafe conduct, or behaves violently or destructively may be immediately removed from gameplay at the discretion of the event staff. If a participant damages, destroys, or loses any Battle Party LA equipment, whether through negligence, misconduct, or failure to follow rules, the event host may be billed for repair or replacement. The replacement cost will be determined based on the fair market value of the item, plus any associated losses or damages resulting from Battle Party LA's inability to use that equipment for future events during repair or replacement. Repeated violations or hostile behavior may result in the participant being barred from future events at the discretion of Battle Party LA management.
